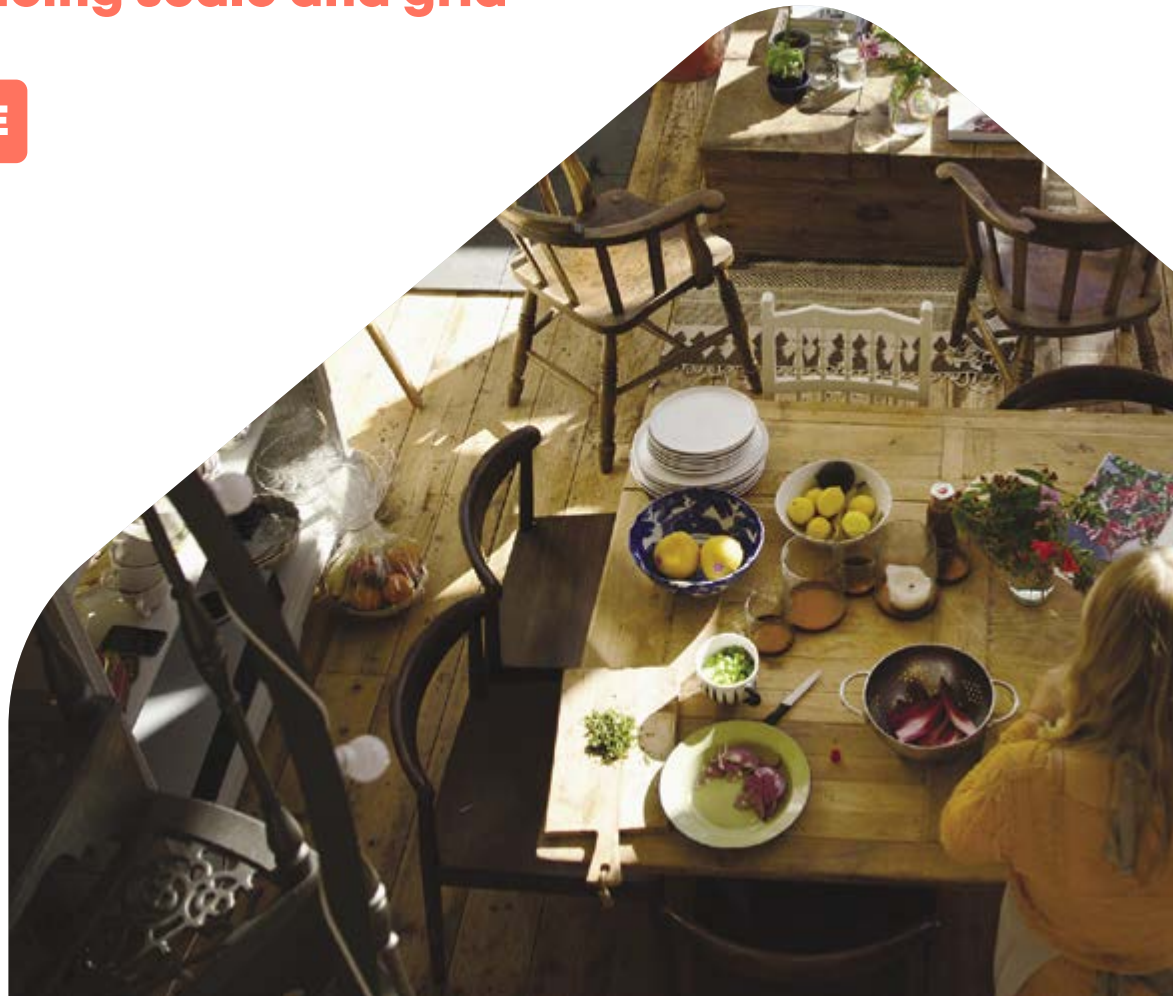

Your eco-fee offers a second life to all household items

This eco-fee pricing scale applies to furnishing items: furniture, seating, bedding, decorative textile items, and accessories.

The eco-fee covers the cost of collecting, sorting, reusing, recycling, and recovering used furniture, and provides support for eco-design and repair, as well as funding projects in research, development, and innovation.

Since 2013, Ecomaison has collected some **10** million tonnes of used furniture and bedding. The reuse of these items and materials has prevented the equivalent of **1000** Eiffel Towers of waste going to landfill. Previously, 55% of discarded furniture was landfilled.

10 years later, it's already less than 3%. Handling 760,000 tonnes per year, Ecomaison has now become France's leading supplier of recycled wood.

Furnishing and fit-out items and components



Kitchen and accessories

Upper and lower kitchen units, panels and doors, tabletops and worktops, bottle racks, cutlery trays, etc.



Bedding and bedroom

Bed bases, mattresses, beds, headboards, duvets, pillows, bed legs, bed-base slats, bedside tables, storage boxes, furnishing covers and textiles, etc.



Storage and fit-out components

Cupboards, storage units and fit-out components (custom or standard), cabinets and dressing tables, wardrobes, walk-in wardrobe components, doors (sliding or standard), accessories and coverings, storage boxes and units, furnishing panels, panels cut to size in all materials, other panels, etc.



Bathroom and accessories

Bathroom furniture, hardware, other accessories, etc.



Furnishing and bedding hardware and accessories

Racks, brackets, doorknobs, door handles, wardrobe rods, rails, sliding drawers, hinges, shelves, caps, etc.



Lounge and living room

Tables, chairs, seats, sofas, cushions, bar furniture, nesting tables, credenzas, sideboards, etc.



Childcare

Cots, chests of drawers, high chairs, etc.



Technical and office furnishings

You must apply the eco-fee to the products concerned as of 1 April 2023.

What does this category cover?



Curtains and net curtains

Curtains (blackout, thermal, acoustic, sheer, mosquito net, etc.), thermal blackout linings, net curtains, tension fabrics, tapestries, wall hangings, etc.



Decorative rugs

Rugs (high or low pile, bedside, faux fur, etc.), faux and genuine animal skin rugs, carpet rugs, etc.



Functional mats and doormats

Mats (hall, stairs, non-slip, hygienic, anti-fatigue, dust-control, etc.), doormats, underlays, etc.



Interior blinds

Skylight, roller, cellular, Venetian, Roman, blackout, pleated blinds, etc.



Removable event carpets

Event carpets for exhibition stands or aisles, acoustic or compact carpets, etc.



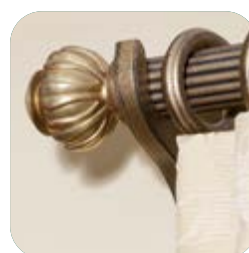

Hanging decorative canvases, kakemono, paintable canvases, decorative paintings with frames, etc.

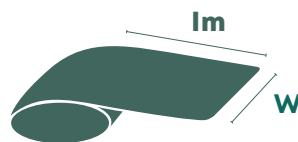

Simplified declaration for small producers



Simplified declaration procedures

In order to streamline the declaration process for producers marketing small quantities of products, Ecomaison offers a simplified, flat-rate system.

Who does this concern?

Any company marketing **less than 15 tonnes per year**.

Each unit weighing less than 2kg is eligible, with no limit on the number of units, up to **the limit of 15 T marketed per year**.

For units of **more than 2kg**, marketing is capped at **1,000 units, up to the limit of 15 T**.

What does Ecomaison offer?

Eligible producers will benefit from the simplified regime when submitting their quarterly or annual declarations.

The **flat-rate scheme operates in brackets of 10 units**.

It can **also be used by marketplaces** (during quarterly declarations) **on behalf of third-party sellers who do not have a unique identifier**.

Definition:

A small producer is a marketer with an annual tonnage of less than 15 T.

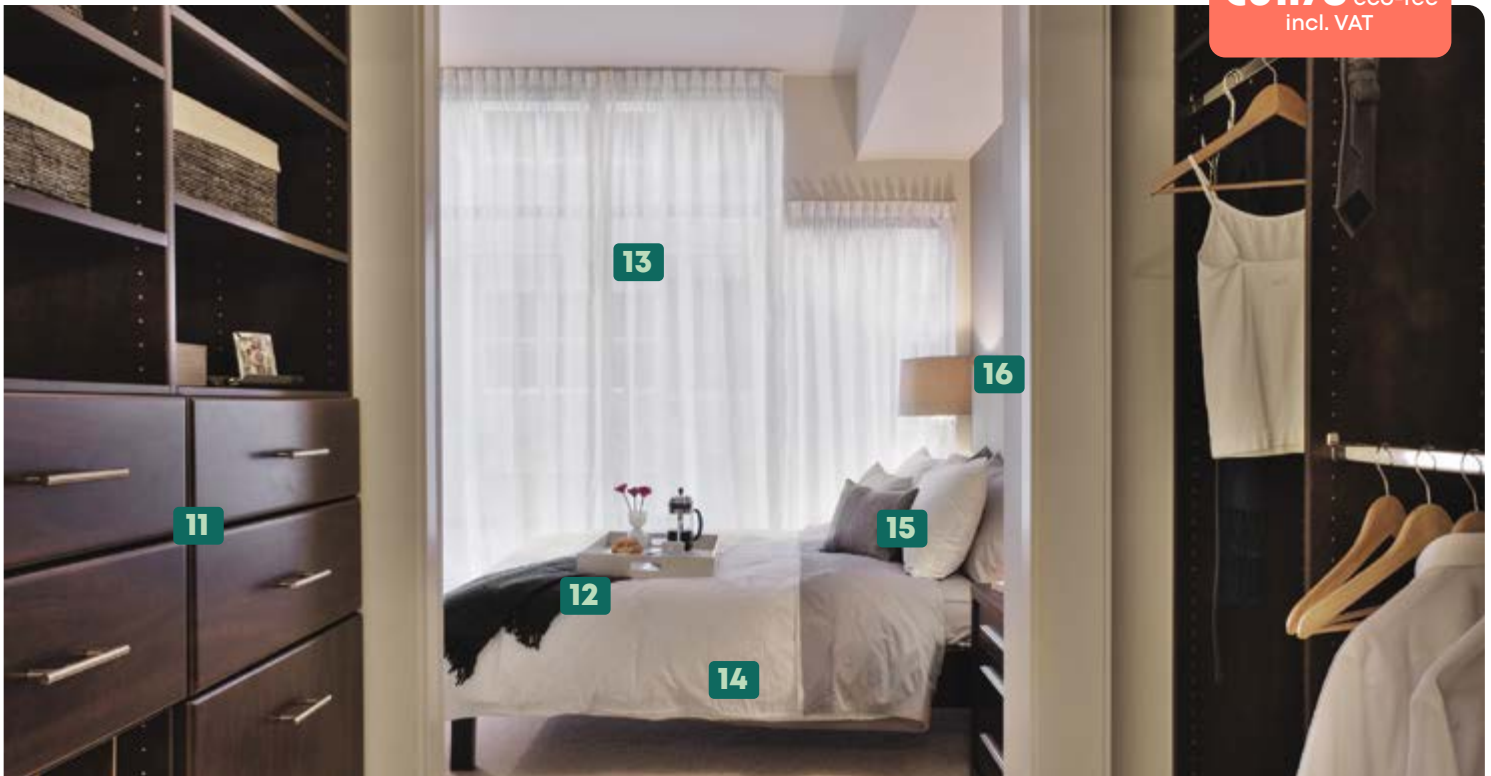

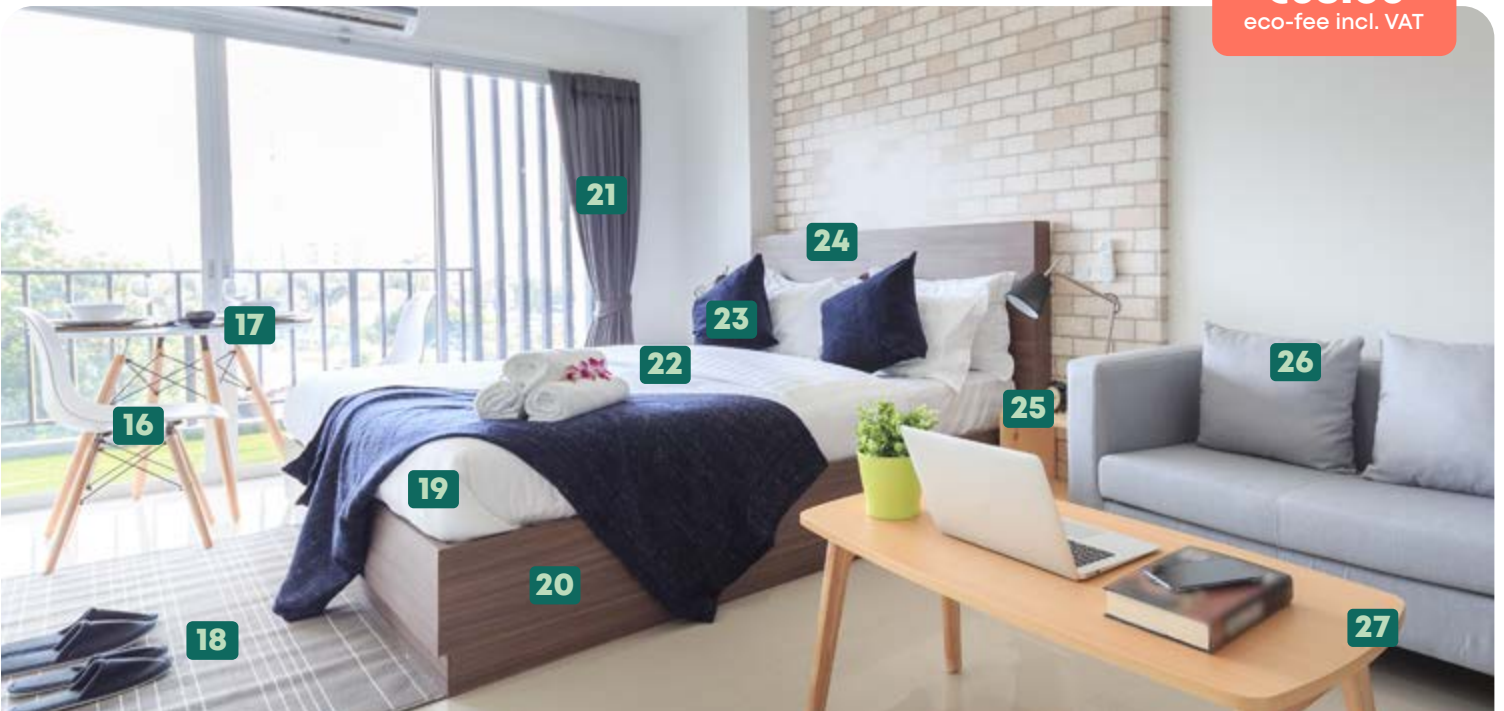

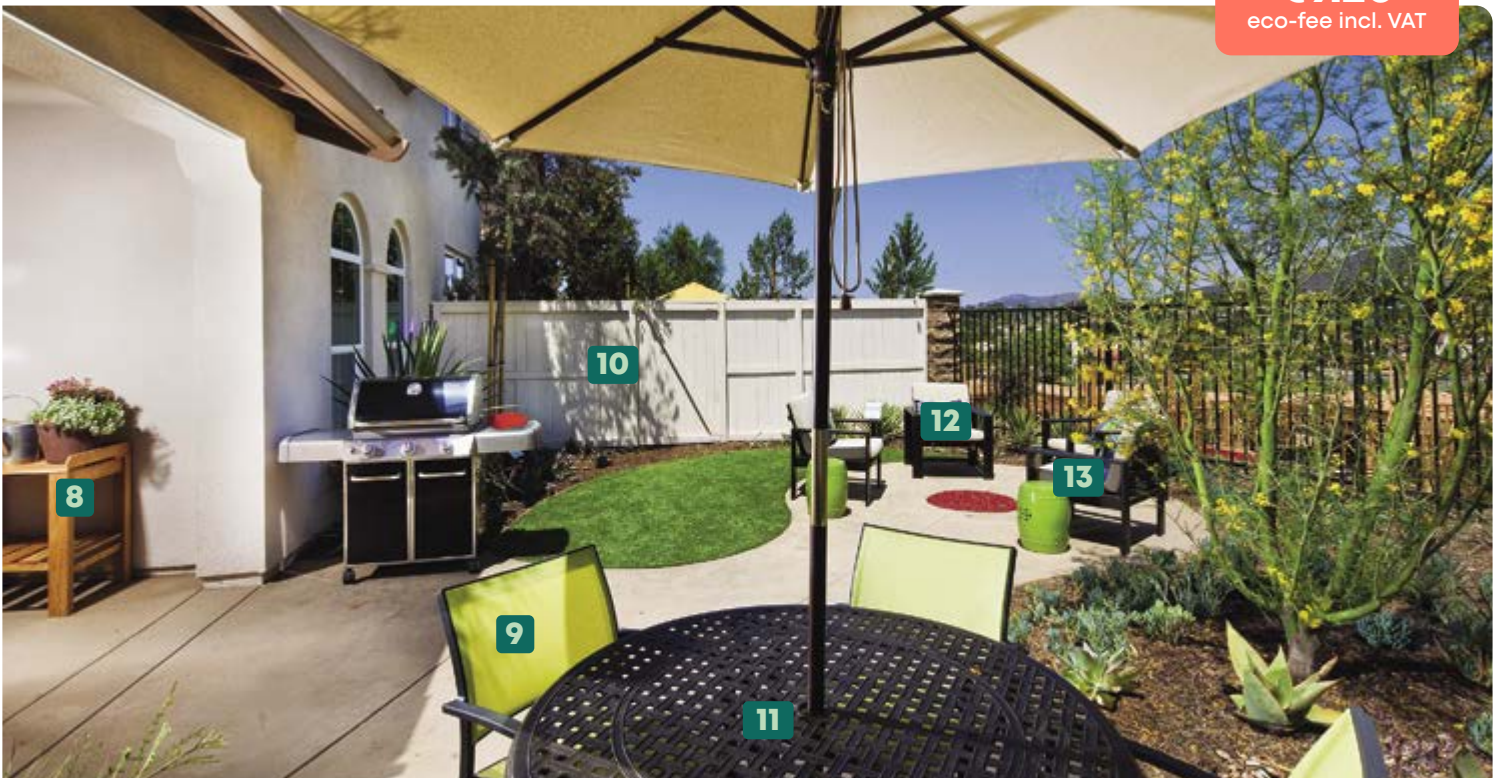
