

#### Frequently Asked Questions (FAQs)

Prevention and eco-design plan

#### 1. Am I concerned by the prevention and eco-design plan?

According to Article <u>72 of the AGEC Law of 10 February 2020</u>, any producer concerned by EPR (Extended Producer Responsibility) mentioned in Article <u>L.541-10-1</u> <u>of the Environmental Code</u> is concerned, namely:

- Maker
- Importer
- Introducer
- Seller under their own name or brand
- Online Product Seller

Thus, this measure applies to all marketers in EPR sectors, particularly those of Ecomaison.

# 2. I am subject to several EPR schemes, do I need to establish several prevention and eco-design plans?

Yes, the anti-waste law for a circular economy known as the AGEC law stipulates that all producers mentioned in Article L.541-10-1 of the Environmental Code are concerned, for all the EPR sectors. Products and materials vary from one EPR sector to another. It is necessary to make different commitments for each EPR sector, to which you are subject as a marketer.

#### 3. Do I have to draw up a prevention and eco-design plan?

Yes, you are required to draw up a prevention and eco-design plan. Nevertheless, the law offers the possibility for eco-organisations to draw up a common plan for one or more EPR sectors, for which they are approved.

Ecomaison has taken the decision to develop and make available to its members a common plan for each EPR sector, to opt. Thus, you have two options to comply with the law:

#### 1. Individual Plan

By opting for the individual plan, you commit to drafting and implementing a set of actions that reflect your company's eco-design strategy. This plan will have to include at least the eco-design axes targeted by the law, namely:

- Reduce the use of non-renewable resources,
- Increase the use of recycled materials and
- Increasing the recyclability of products

This individual plan may be common to several producers or groups of companies.

#### 2. Plan common to your sector

By opting for the common plan for a sector, you commit to taking into account and implementing a set of actions shared by all the players in the sector and validated by the representatives of your profession.

### 4. I am a distributor, a marketplace or an importer, how should I write my voluntary eco-design commitments?

To be in full compliance with the AGEC law, we recommend at least to indicate an action for each of the three axes targeted by the law, namely:

- Reduce the use of non-renewable resources,
- Increase the use of recycled materials and
- Increasing the recyclability of products.

The framework also offers the possibility to go beyond the regulatory response and allows you to plan and promote your voluntary commitments in favour of a circular economy.

Marketers who are not directly involved in the design of products can complete the prevention plan by indicating the measures they wish to take in terms of eco-selection. For example, by integrating environmental criteria into the purchasing specifications, when selecting manufacturers/suppliers.

# 5. How do I submit my individual prevention and eco-design plan?

The individual prevention plan must be submitted on<u>the Service Area</u> in your connected space, at the bottom of the page in the "Write your prevention and ecodesign plan" section or « Rédigez votre plan de prévention et d'éco-conception » in French.

# 6. What is the deadline for submitting my individual prevention and eco-design plan ?

Please submit your individual prevention and eco-design plan on <u>https://espace-services.eco-mobilier.fr/guide-de-redaction-du-plan-de-prevention-et-deco-conception the Service Area</u> or attach yourself to the common plan for each sector concerned in your dedicated space, before the following dates :

# 7. What is the duration of the objectives listed in the prevention plan?



The regulations stipulate that this plan must be reviewed at least every 5 years. This is not to say that targets should be set over a five-year period; They can be defined in the shorter or longer term.

### 8. What will my individual prevention and eco-design plan be used for?

In addition to the regulatory response, the prevention and eco-design plan allows you to plan and promote your voluntary commitments.

In addition, eco-organisations are required to draw up a summary of prevention and eco-design plans every three years and to transmit them to the public authorities, this summary will be publicly accessible.

#### 9. What penalties do I face?

The reglementation does not mention the penalties incurred in the event of nontransmission of the plan.

Nevertheless, <u>Article L541-9-5</u> stipulates that in the event of a finding of noncompliance, marketers are liable to an administrative sanction "the amount of which takes into account the seriousness of the breaches observed and the benefits derived from them.

This amount may not exceed, per unit or per tonne of product concerned,  $\leq 1,500$  for a natural person and  $\leq 7,500$  for a legal person. The decision shall state the time limit and manner in which the fine is to be paid. The French Minister for the Environment may also, under the same conditions, order the payment of a daily penalty payment of not more than  $\leq 20,000$  from a date fixed by the decision until the prescribed measures have been complied with. »

### 10. What support does Ecomaison provide to complete the individual plan?

We propose a common framework for four eco-organizations:

• **Ecomaison** for the management of objects and materials in the home: furniture, bedding, toys, DIY and garden items.



- **Citeo** for the management of household packaging and graphic papers.
- **Ecosystem**, for the management of waste electrical and electronic equipment.
- **Refashion** for the textile, clothing, household linen and footwear sector.

As well as a writing guide that you will find in the PPE Drafting Guide.

To support its members, Ecomaison has chosen to put them in a common plan for each sector concerned. Each member can thus decide to share an individual plan or to join a common plan for each EPR sector concerned.
