Furnishing and fit-out items and components



Kitchen and accessories

Upper and lower kitchen units, panels and doors, tabletops and worktops, bottle racks, cutlery trays, etc.



Bedding & bedrooms

Bed bases, mattresses, beds, headboards, duvets, pillows, bed legs, bed base slats, bedside tables, storage boxes, covers and furnishing textiles, etc.



Storage & fit-out

Cupboards, storage units and fit-out components (custom or standard), cabinets/dressing tables, wardrobes, dressing room components, doors (sliding or standard), accessories and coverings, storage boxes and units, furnishing panels, cut-to-size coated panels, panels, etc.



Bathroom and accessories

Bathroom furniture, hardware and other accessories



Hardware and accessories for furniture and bedding

Racks, brackets, knobs, door handles, wardrobe rails, rails, drawer runners, hinges, shelves, end caps, etc.



Lounge & living room

Tables, chairs, seats, sofas, cushions, bar furniture, nested tables, dressers, sideboards, etc.



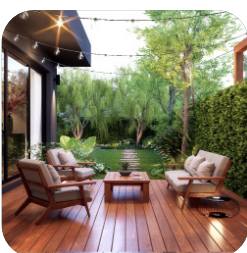

Details of decorative textile items

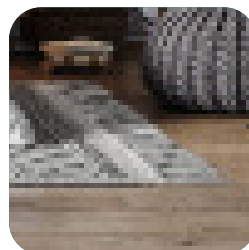

What does this category cover?



Curtains and net curtains

Curtains (blackout, thermal, acoustic, sheer, mosquito net, etc.), thermal blackout linings, net curtains, tension fabrics, tapestries, wall hangings, etc.



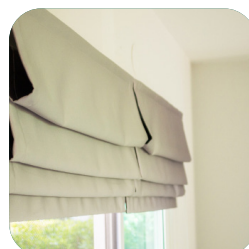
Decorative rugs

Rugs (high or low pile, bedside, faux fur, etc.), faux animal skin rugs, carpet rugs, etc.



Functional mats and doormats

Mats (hall, stairs, non-slip, hygienic, anti-fatigue, dust-control, etc.), doormats, underlays, etc.



Interior blinds

Skylight, roller, cellular, Venetian, Roman, blackout, pleated blinds, etc.



Removable event carpets

Event carpets for exhibition stands or aisles, acoustic or compact carpets, etc.



Small decorative textile items

Macramé, hanging decorative textile items, decorative garlands, etc.



Textile wall frames

Decorative hanging canvases, kakemonos, painting canvases, decorative paintings with frames, etc.



Hanging accessories

Rods, rings, hanging strips, rod buttons, clothes rails, corner sets, etc.



Remember to apply the eco-participation to all **small furnishing items** and **their accessories** intended for the home or garden (bathroom, kitchen, living room, bedroom, etc.), shops or public reception areas.

This also applies to **childcare** and **children's** furniture (changing tables, observation towers, bed skirts, travel cots and cododo cribs, cradles, booster seats, bed canopies, cuddly toy hammocks, toy chests, etc.) and pet furniture (cat trees, mattresses, cushions, hammocks, aquarium furniture not including the aquarium, etc.).

Small storage items are also included (coat hangers, pencil pots, utility holders, trunks, coat racks, toilet brush holders and coin boxes), as are massage tables, picnic tables and ironing boards.

Products are classified within the families according to the **primary material** used:

- Wood and bio-sourced materials, depending on whether or not they come from sustainably managed forests
- Other materials, including metal and plastic resins Ceramic, etc.

Description of the materials used in the scale

- **Solid wood**, such as plywood and laminated panels, 3-ply, glulam, more than 95% by mass (metal may be present), or between 75% and 95% by mass.
- **Coated chipboard**, with a decorative finish (painted, lacquered, foil or melamine), OSB, more than 75% by mass
- **All types of wood and wood derivatives**, including wood and wood derivative assemblies, primary material by mass.
- **Bio-sourced material**: manufactured from renewable organic materials, i.e. animal or plant matter.
- **Mineral materials**: natural stone, terracotta, ceramic, concrete, etc.
- **Plastic resin**: PE, PP, ABS, PLA

Recycling barriers

Chemical barriers include:

- The list of hazardous substances in pursuance of France's AGEC Law (Art. 13), i.e. SVHC substances within the meaning of the REACH Regulation in quantities greater than 0.1% by mass
- Substances classified under Annex XVII of the REACH Regulation in quantities above the specified limit
- Substances subject to the POPs Regulation (Annex 4)
- Substances likely to classify the waste as hazardous within the meaning of the Waste Framework Directive

Physical barriers:

- Materials or assembly methods that complicate the process of extracting / separating recyclable materials or which compromise the quality of the waste stream to be recycled. Mineral materials (ceramics, mirrors, glass, etc.) are considered to be barriers for all products. For mattresses with non-separable springs embedded in the foam are considered to be barriers.



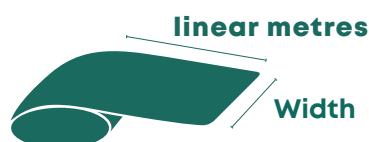

Simplified declaration procedures

Ecomaison offers a simplified flat-rate scheme to streamline the declaration process for producers marketing small quantities of products.

Who does this concern?

Any company marketing less than 15 tons a year.

Each piece weighing less than 2 kg is eligible, with no limitation in terms of the number of pieces, and within the limit of 15 tons marketed per year.

For units weighing over 2 kg, a maximum of 1,000 pieces may be placed on the market, up to a limit of 15 tons.

What does Ecomaison offer?

Eligible producers will benefit from the simplified scheme when submitting their quarterly or annual declarations.

It can also be used by marketplaces (for quarterly declarations) on behalf of third-party sellers without a unique identifier.

Definition:

Small producer: a company placing less than 15 tons on the market a year.
