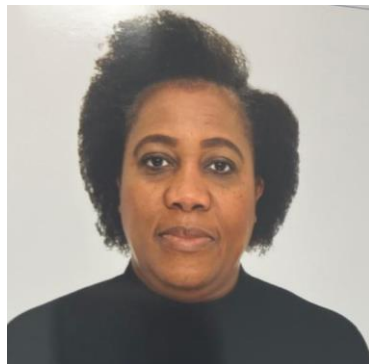

► Who are we?

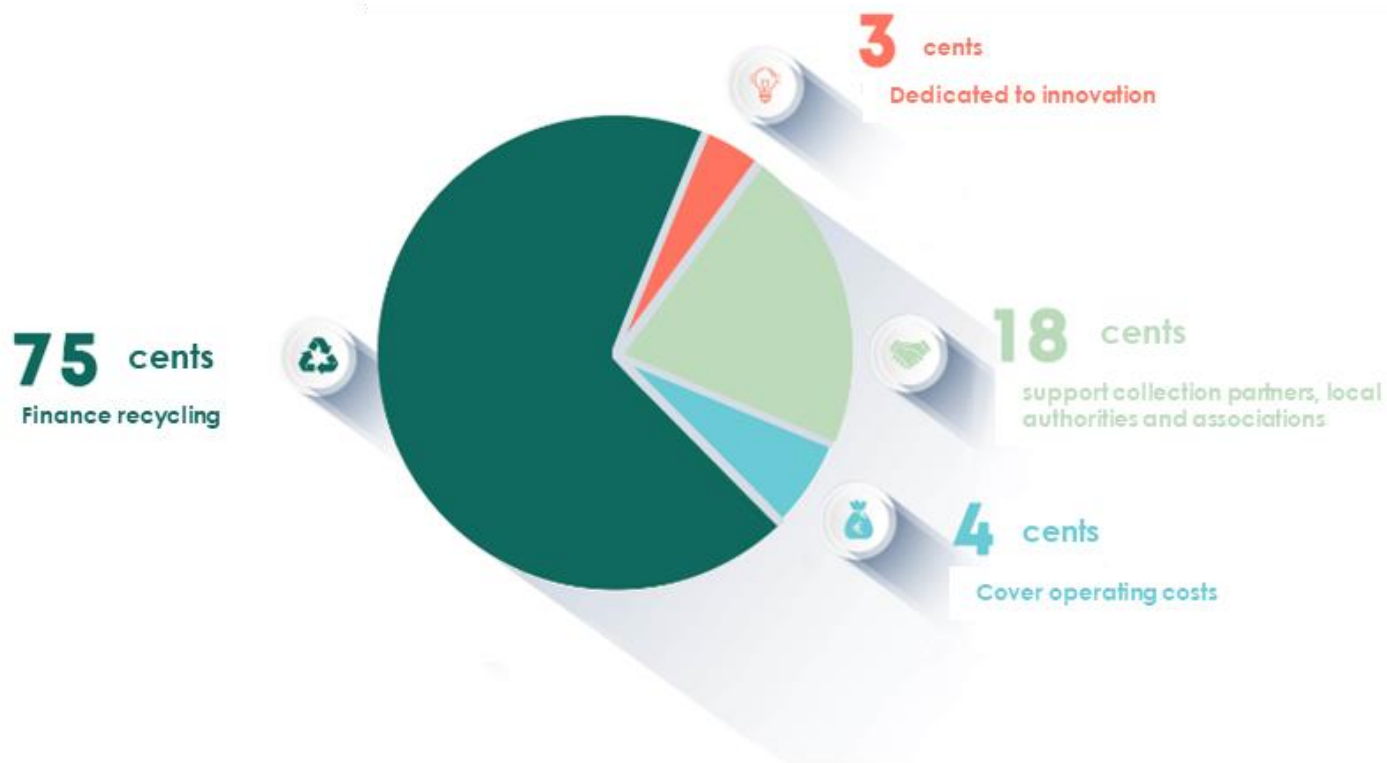
Created in 2011 under the name of Eco-mobilier, we are a **non-profit organization** approved by the French State and funded by eco-fees paid by consumers in France.

► Our mission

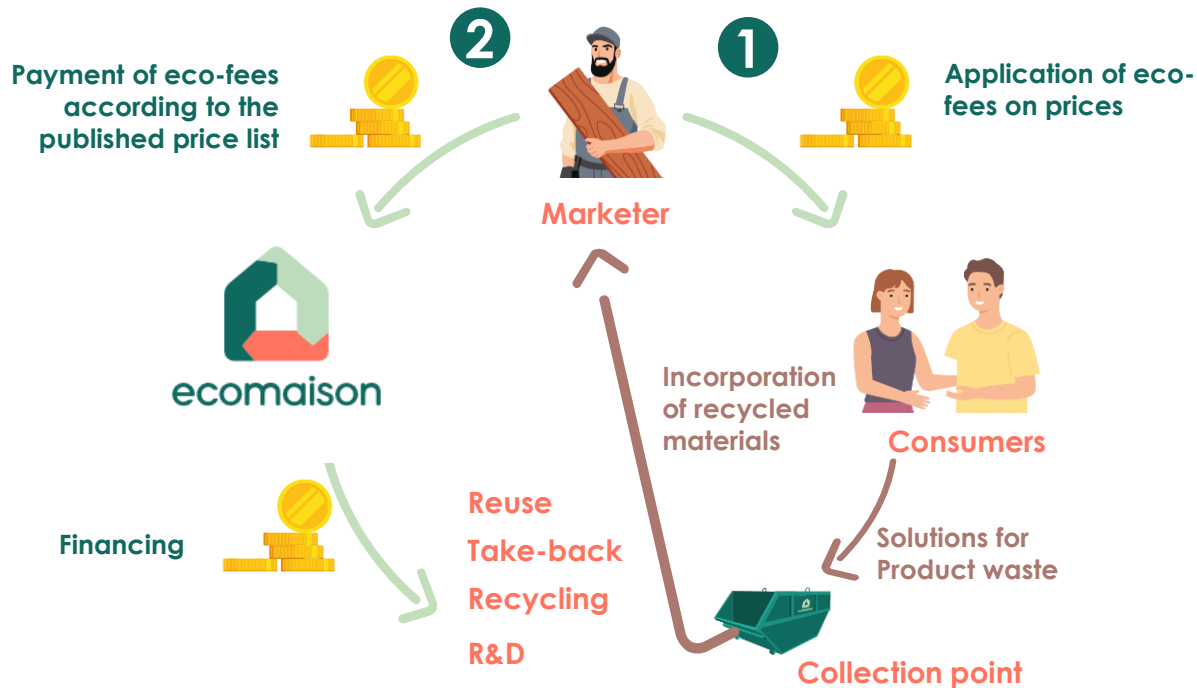
To **collect and recover used household items and materials** and offer them a second life by recycling them or using them as a source of energy. With 760,000 tons per year, Ecomaison has become the 1st supplier of recycled wood in France.

How the eco-fees is collected



The eco-fee is applied identically at each stage of the product distribution chain, through to the end customer.

The eco-fees for furniture must be displayed on sales documents : catalogues, receipts, website, price tags,

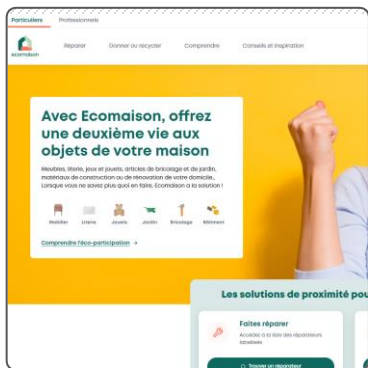

In 2023, Ecomaison handled 1.6 million tonnes of used products, 97% of which were recovered (reuse, recycling, energy recovery).



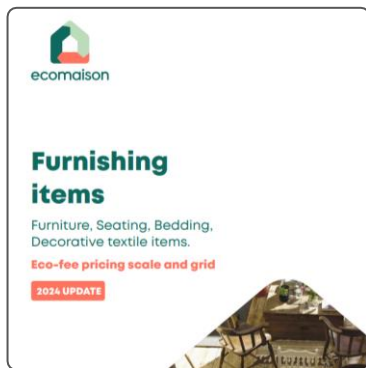



2. Changes to the 2024 annual **furniture** declaration



Craftsmen : end of exemption

► The Exemption for craftsmen is abolished



- **January of 2024**: Craftspeople have completed their exemption application for the year 2023.
- **Year 2024**: throughout the year, they have applied the eco-participation to their marketings.
- **1st January of 2025**: craftspeople complete their first declarations using **simplified coding** or **standard coding**.

Former "Small Producer" scale criteria valid for 2023 marketings.

Until 2023, the simplified procedure for declaring new products on the market was based on sales.

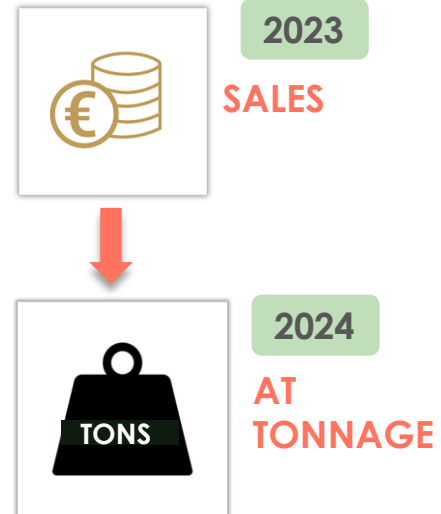
New for the declaration: the disappearance of the flat-rate declaration

► The regulations now require tonnage marketed to be the criterion for simplified declaration procedures.

- The criterion is no longer marketing sales, but the tonnage marketed (15 tonnes per year).
- The « flat-rate declaration » is being replaced by simplified coding.

To be implemented for marketing in 2024, first declaration on January 1^{er} 2025.

- ▶ Eco-participations are now given on a unit basis.
- ▶ You can choose to continue coding in increments of 10 units.

► Am I a "Small Producer" for building materials and products?

Craftsmen, retailers and manufacturers **with annual sales of less than €1 million** for building-related products and materials **not already invoiced with eco-participation** are considered small producers.

► Principle

This declaration is calculated on the **basis of a percentage** of your **annual sales of products subject to EPR (Extended Producer Responsibility)** for the **previous calendar year**. This percentage **may vary according to the principal activity**.

Simplified scale : BUILDING

► How do you calculate your sales and eco-participation?

It is made up of two main components:

- Purchases of raw materials, which will be processed into finished products;
- Manufacturing, installation or any other service related to the use of these elements on building sites.

Display the eco-participation



Eco-participation display : Furnishing items including textile decoration



Visible contribution: mandatory signage for sales to professionals and private individuals


"For all sales of furnishing elements before January 1^{er} 2026, producers and successive intermediaries must indicate on sales invoices the unit costs they incur for the management of waste furnishing elements." [Article R543-247 of the French Environment Code](#)

Eco-participation must be passed on equally throughout the chain.



From April 1^{er} 2023: Mandatory display of eco-participation for textile decoration items

For the marketer: potential administrative fine (3^e class contravention) for failure to display the eco-participation. [Article L541-9-4 of the French Environment Code](#).



Several eco-fee display methods

- Method 1: €179,00 incl. €2.20 eco-fee
- Method 2: €179,00 incl. €2.20 eco-contribution
- Method 3: €176,80 Eco-fee of €2.20 / €179,00

For small third-party sellers



- ▶ The simplified system can be used by **small third-party sellers for annual or quarterly declarations. Marketplaces** also have this **same simplified coding** for declaring **their non-compliant sellers**.

Quarterly declaration required for marketplaces



Dedicated coding directly integrated into the product code generator

...I am a maker / producer

- ▶ I sell my product directly to the French consumer
- ▶ My product is sold by a distributor to French consumers.
- ▶ I ship my product directly to the French consumer, but it is sold by a distributor.
- ▶ I sell my product via marketplaces.

...I am a distributor

- ▶ I import my products from a foreign company (Europe & Outside Europe).
- ▶ I sell private label products.
- ▶ I sell products from foreign companies via marketplaces.
